




Subj: Department Bylaws and Administrative Procedures Changes Approved at the 2011 Department Convention.

1. Background. During the Department Convention held in San Diego, California there were eleven proposed changes to the bylaws addressed, and were adopted.

2. Purpose. To transmit new page inserts to the Department Bylaws.

3. Action. Remove current pages 1-1, 1-2 and 1-3, 2-1, and 2-2, 2-3, and 3-3, 3-4 and 5-5, 6-1 and replace with enclosed pages 1-1, 1-2, and 1-3, 2-1, and 2-2, 2-3, and 3-3, 3-4 and 5-5, 6-1.

4. Summary of Changes.

A. Amended Article I by inserting a provision on eligibility requirements.

B. Amended Article I, Section 120 by deleting the wording in reference to nominees.

C. Amended Article I by deleting Section 120 A, which is incorporated into Section 116.

D. Amended Article I, Section 125 C. by striking out the words ballot(s) and balloting throughout, and inserting the word "vote".

E. Amended Article I, Section 131 by inserting sub-paragraph A and the words, "The installation of Department Officers will be conducted immediately subsequent to their election or appointment.

F. Amended Article II, Section 205 by deleting sub-section C referencing the bonding of the Department and Detachment Commandants and Paymasters.

G. Amended Article II, Section 210 D. 4. By inserting, "registry letter from the Registry of Charitable Trusts"


H. Amended Article III, Section 310 by deleting sub-section A 4, the requirement for the Department Adjutant to maintain a permanent record of recipients of the Distinguished Citizens Medal.

I. Amended Article III, Section 310 L by deleting in its entirety and inserting new wording on the duties of the Regional Coordinator.

J. Amended Article III, Section 310 L by deleting in its entirety the duties of the Training Officer.

K. Amended Article V, Section 565 D by inserting the words, " letter of registration from the Registry of Charitable Trusts".
